

## Camp Sunshine at Home Winter 2021: Frequently Asked Questions

- **What are my options?**
  - Families may choose to participate in one of two Camp Sunshine: Together at Home virtual programs (which includes a Box of Sunshine, of course!), or the Box of Sunshine: Winter Edition only. The dates for the virtual program are 1: Feb 19 – 21 or 2: Feb 26 – 28.
- **Who is eligible to participate?**
  - Programs are for families with a child 18 years old or younger with one of the following diagnoses:
    - Cancer
    - Retinoblastoma
    - A brain tumor
    - Kidney disease
    - Solid organ transplant recipients
    - Sickle cell disease
    - Other hematologic conditions including:
      - immune thrombocytopenic purpura (ITP), thrombotic thrombocytopenic purpura (TTP), aplastic anemia, beta thalassemia major, thrombocytosis
  - Systemic lupus erythematosus (SLE) (age 21 and younger)
  - We regret that due to shipping costs, we are only able to mail boxes within the US and Canada. The program is designed for the immediate family: parents and children. If you know of a family who meets our eligibility criteria, please spread the word!
- **I would like to refer a new family. Can I share the registration link with them?**
  - Yes! If you know of a family who meets our eligibility criteria and could use some “Sunshine”, please spread the word!
- **Will participation in either of these programs impact my family’s eligibility to participate in any in-person programs that may be offered later this program year?**
  - No. Participation in either program will not affect your eligibility to attend in-person this program year.
- **On that note: what are your dates for in-person programs in 2021?**
  - While we look forward to resuming our in-person programming, we do not yet have plans to announce. We will continue to evaluate when and how it will be safe to resume in-person programming. Please make sure to follow us on social media for updates.
- **If I sign up for the Together at Home program, am I required to participate in each of the 3 nights of live programming?**
  - While we hope you can, you are not required to. It is not required that all family members participate on any given night, however at least one adult must participate with children under 18.
- **Does Camp Sunshine: Together at Home include live programming during the day, or is it only in the evening?**
  - Together at Home live programs are only in the evenings, for the whole family. The idea is that the Box of Sunshine activities will be used during the daytimes of your “session” dates.
- **We miss the volunteers! Will we get to see them?**
  - Get ready for some “on-demand” content from some of our incredible volunteers, available for both Box of Sunshine and Together at Home participants. Volunteers will also be participating in the Together at Home sessions!
